4. The customer hereby consents to the jurisdiction of the Magistrates’ Court in respect of any action to be instituted against it pursuant to this contract. It shall nevertheless be entirely within the supplier’s discretion as to whether to proceed against the customer in such Magistrates’ Court or any other court having jurisdiction.
5. I / We warrant that I am authorized to make this application of behalf of the debtor.
6. I warrant that the details of the debtor as in the attached appendix are true and correct in every respect.
7. I agree that the credit limit specified in the appendix may be increased from time to time without limiting the creditor’s right to recover any outstanding amounts. However, I accept that the supplier still reserves the right to request a signed “Increase in credit limit” form.
